

INSTALLATION:

- Adjust regulator to desired secondary pressure.
- Snap off adjusting knob by rotating the panel nut counterclockwise to lift the knob off.
- 3. Align the three legs of the tamper resistant ring with the three mating slots in the bonnet.
- 4. Reposition the adjusting knob on to the bonnet and snap in place.

Note: It may be necessary to rotate the adjustment knob slightly to assure it engages the tamper resistant ring.
